**COMMITTEES**

**Appraisal Committee** – Creates meeting opportunities for Appraisers to discuss Local issues.

**Attorney Interaction Committee** – Formed to create a working relationship with local attorneys and the Richmond County Bar Association to improve the Real Estate transaction.

**Broker & Agent Roundtables Committee** – Coordinates the monthly forum for Broker/Owners, Managers and Agents, and also participates in New Member Orientation programs.

**Budget & Finance Committee** – Oversees the preparation of the annual budget and SIBOR's financial investments. (Composition defined by Bylaws)

**Builders Committee** – Intended to create a working relationship with local builders and the Builder's Association to improve conditions.

**Bylaws Committee** – Maintains the governing documents of SIBOR. Reviews requirements of the National Association of Realtors® (NAR), the New York State Association of Realtors® (NYSAR) and local requirements to maintain the Bylaws, Policies and Procedures.

**Government/Legislative Affairs Committee** – Educates members on the importance of political awareness and active political involvement; keeps members informed on legislative issues related to our industry; identifies political candidates who support private property rights and other positions supportive of the real estate community, and coordinates the distribution of RPAC funds to local elected officials and candidates for elected positions.

**Grievance Committee** – Carries out the initial review of Ethics complaints and financial disputes and refers them, when appropriate, to the Professional Standards Committee for hearings. **Members are required to take an annual one-day training program**, conducted at SIBOR in January. **International Real Estate Committee** – Encourages Realtors® to have a global perspective and coordinates an Annual Symposium.

**Nominating & Awards Committee** – Identifies, recruits and nominates Officers, Directors, and annual recipients of the Realtor® and Realtor Associate®-of-the-Year, and other Recognition Awards. (Composition defined by Bylaws)

**Professional Standards Committee** – This pool of volunteers is used to compose hearing panels that arbitrate disputes and conduct Code of Ethics hearings in accordance with procedures established by the National Association of Realtors®. **Members are required to take an annual one-day training program**, conducted at SIBOR in January. **Public Relations Committee** – Oversees SIBOR Media and Internet marketing campaigns and websites in an effort to increase the public's awareness of Realtor® value.

**SIBOR Russian Speaking Committee** – Addresses the needs of this membership segment.

**SIBOR Young Professional Network (YPN)** – Creates a voice for the younger Realtor® and addresses their particular needs and interests.
